



**Invitation to Bid

#2824 Dewey Robbins Road "Part" and #2625 South Dewey Robbins Road "Part" Paving Project No. 2008-07.

Sealed bids will be received by the Office of Procurement Services, on behalf of the Lake County Board of County Commissioners, until 10:00 a.m. on August 14, 2008, for the furnishing of all services, labor, materials and equipment for the construction of the following project: Bid No. 08-0031, #2824 Dewey Robbins Road "Part" and #2625 South Dewey Robbins Road "Part" Paving Project No. 2008-07.

This project is located off US-27 south of Leesburg and is approximately 7,725' +/- in length. The construction shall consist of building 24' in width roadways from Turkey Lake Road to East Dewey Robbins Road using 12" Type B stabilized subbase (40 LBR, 98% compaction), 8" limerock (two lifts, 98% compaction), prime and sanded, and 2" minimum type S-III asphaltic concrete (two lifts). Other work shall include the construction of swales, ditch blocks, installation of stormpipe, driveway construction, roadway signs, thermoplastic striping and other miscellaneous incidental construction.

All bids shall be received no later than the date and time specified above, at which time they will be publicly opened and read aloud in the Office of Procurement Services, Fourth Floor, Administration Building, Room 416, 315 West Main Street, Tavares, Florida.

Bids may be withdrawn prior to the date of opening, but no bids may be withdrawn for a period of sixty (60) days after the date of opening of bids.

The Board of County Commissioners reserves the right to reject any or all bids, to waive formalities, and to award the contract in the best interest of Lake County, Florida.

All bids must be accompanied by a Bid Guarantee acceptable to the County Attorney, which shall be one of the following; a certified check, cashier's check, trust company treasurer's check, bank draft of any national or state bank or bid bond, in the sum of five percent (5%) of the base bid and made payable to Lake County. Said check, draft or bid bond shall be a guarantee that should the bid be accepted, the bidder will, within ten (10) days after written notice of the award of the contract, enter into a contract with Lake County for the services proposed to be performed and will at that time furnish an acceptable contract surety. Cash, company or personal checks will not be accepted.

A non-mandatory pre-bid conference will be held on July 31, 2008 at 11:00 a.m. in the Department of Public Works' conference room, located at 437 Ardice Avenue, Eustis, Florida 32726.

specifications, and bid forms prior to the non-mandatory pre-bid conference so that questions may be presented at that time.
