Lake County participates in the National Flood Insurance Program (NFIP). The NFIP makes federally backed flood insurance available for all buildings (whether inside or outside of a floodplain). Flood insurance covers direct losses caused by surface flooding, including a river flowing over its banks, a lake or ocean storm, and local drainage problems.

Lake County joined the Community Rating System (CRS) through the National Flood Insurance Program (NFIP) in 1982. As a result of steps taken by Lake County Officials, Unincorporated Lake County is now rated as a Class 7 Community. Flood insurance issued, or renewed, for property located in the Special Flood Hazard Areas (SFHAs) beginning May 1, 2009 will receive a 15% premium discount.
