Dillard Street Sidewalk and CR-48 Bike Path Addition

Sealed bids will be received by the Office of Procurement Services, on behalf of the Lake County Board of County Commissioners, until 10:00 a.m. on July 8, 2010 for the furnishing of all services, labor, materials and equipment for the construction of the following project: Dillard Street Sidewalk and CR-48 Bike Path Addition Project No. 2010-20, Bid No. 10-0043.

Dillard Road Sidewalk project is located along Dillard Road in Eustis and entails the installation of a 5' in width sidewalk in several locations along Dillard Road between Huffstetler Drive and CR-19A. Other work for this project shall include the following: sodding, thermoplastic striping, and other miscellaneous incidental construction.

CR-48 Bike Path Addition project is located on CR-48 in Yalaha and shall consist of installing an asphalt bike path 6' in width. Other work associated with this project shall include the following: sodding, striping, roadway sign installation, and other miscellaneous incidental construction.

All bids shall be received no later than the date and time specified above, at which time they will be publicly opened and read aloud in the Office of Procurement Services, Fourth Floor, Administration Building, Room 416, 315 West Main Street, Tavares, Florida.

Bids may be withdrawn prior to the date of opening, but no bids may be withdrawn for a period of sixty (60) days after the date of opening of bids.

The Board of County Commissioners reserves the right to reject any or all bids, to waive formalities, and to award the contract in the best interest of Lake County, Florida.

All bids must be accompanied by a Bid Guarantee acceptable to the County Attorney, which shall be one of the following; bid bond or letter of credit, in the sum of five percent (5%) of the base bid and made payable to Lake County. Said bid bond or letter of credit shall be a guarantee that should the bid be accepted, the bidder will, within ten (10) days after written notice of the award of the contract, enter into a contract with Lake County for the services proposed to be performed and will at that time furnish an acceptable contract surety. Cash, company or personal checks will not be accepted.

A non-mandatory pre-bid conference will be held on June 17, 2010 at 9:00 a.m. in the Department of Public Works' conference room, located at 437 Ardice Avenue, Eustis, FL 32726.

The bidding document will be available for purchase on June 10, 2010 at the Department of Public Works. Bidders are encouraged to purchase and review the plans, specifications, and bid forms prior to the non-mandatory pre-bid conference so that questions may be presented at that time.
