

**AMENDMENT TO AGREEMENT  
BETWEEN

FOR  
BOOK LEASING SERVICES**

THIS AMENDMENT TO AGREEMENT is made by and between Lake County, Florida, a political subdivision of the State of Florida, hereinafter the "COUNTY", and Baker & Taylor, Inc., n/k/a Baker & Taylor, LLC, a foreign limited liability company, hereinafter "B&T", for book leasing services.

**WHEREAS**, the Lake County Library System is a cooperative of branch libraries and municipal libraries, and through interlocal agreements provides access to a full range of library services throughout Lake County; and

**WHEREAS**, each library maintains its own collection and provides for interlibrary loans; and

**WHEREAS**, B&T offers a book leasing service, which would allow COUNTY to offer library patrons access to books in high demand without the delay that occurs when a limited number of such books are in circulation at all the libraries in the system; and

**WHEREAS**, leasing high-demand books through B&T's collection would promote efficiency, because COUNTY would not have to add a large number of high-demand books to its permanent collection for which demand and interest subsequently wanes; and

**WHEREAS**, the parties did enter into an Agreement dated June 26, 2012 for book leasing services; and

**WHEREAS**, the parties now desire to amend the original Agreement in order to allow B&T to continue to provide leased books to COUNTY.

**NOW, THEREFORE**, in consideration of the mutual benefits, covenants and agreements set forth herein, the parties hereto agree as follows:

1. **Recitals.** The foregoing recitals are true and correct and incorporated herein by reference.

2. **Amendment.** Section 4A of the original Agreement dated June 26, 2012, shall be amended to extend the term of the Agreement to automatic one (1) year renewals, beginning June 26, 2015, until such time as one of the parties terminates this Agreement in accordance with the applicable provisions contained herein.

3. **Amendment.** Section 5A, Exhibit A, of the original Agreement dated June 26, 2012, shall be replaced with the revised Exhibit A, attached hereto and incorporated herein by reference, effective June 26, 2015.






