

**RESOLUTION
1995 - 205**

WHEREAS, the State of Florida, through the Conservation and Recreation Lands Program, has established an acquisition program for the purposes of identifying and purchasing environmentally sensitive lands and unique natural resources; and

WHEREAS, the State of Florida, through the Conservation and Recreation Lands Program, has identified certain areas located within Lake County that consist of environmentally sensitive lands and unique natural resources; and

WHEREAS, the Conservation and Recreation Lands Program has established the Wekiva-Ocala Greenway and green Swamp acquisition projects as areas which are consistent with the goals of the program; and

WHEREAS, the Board of County Commissioners of Lake County has become aware that the Land Acquisition Advisory Council of the Conservation and Recreation Lands Program may consider the addition of approximately 2,256 acres to the northern area of the Wekiva-Ocala Greenway project; and

WHEREAS, the Board of County Commissioners has determined that the interests of its citizens are enhanced through the opportunities afforded by the Conservation and Recreation Lands program;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF LAKE COUNTY FLORIDA that:

Section 1. That the Board of County Commissioners of Lake County does hereby declare its support for the purposes and goals of the Conservation and Recreation Lands Program; and

Section 2. That the Board of County Commissioners of Lake County does hereby declare its support for the addition of approximately 2,256 acres to the northern area of the Wekiva-Ocala Greenway project; and

Section 3. That the Board of County Commissioners of Lake County does hereby urge the State of Florida to continue to actively and expeditiously pursue the acquisition of lands within the Wekiva-Ocala Greenway and Green Swamp project areas.
