Ordinance No. 1997-35, effective 5/29/97, created the Lake County Citizens' Commission for Children as a Permanent Advisory Board. Members will begin two year terms on May 15th of each year with eight members appointed during even years and seven members appointed during odd years.

Ordinance No. 2005-87, effective 10/11/05, changed the name of the Lake County Citizens' Commission for Children to the Lake County Children's Services Council.

Ordinance No. 2012-38, effective 7/6/12, amended Section 2-90.27 of the Lake County Code, regarding the Membership of the Lake County Children's Services Council, amending the first category of membership by allowing the Board of County Commissioners to appoint individuals without regard to their district residency in the event that there are no applicants for membership from a particular commission district or districts.

- ❖ **Members must be registered Lake County voters.**
- ❖ **All seats are advertised on the Notice of Vacancies except Superintendent of Schools and DCF Representative.**

Membership shall consist of fifteen (15) members. All members shall be electors of Lake County. Members will begin two-year terms on May 15th of each year. The BCC shall appoint members to staggered terms with eight (8) members appointed during even years and seven (7) members appointed during odd years as follows:

Two (2) members from each Commission district, three (3) at-large members, the District Administrator or named designee from the Department of Children and Families, and the Superintendent or named designee from the Lake County School Board.

In the event there are no eligible applicants, the BCC may appoint any eligible individual regardless of district residency.

The Council shall hold meetings as needed to fulfill its duties, but the Council shall hold at least one (1) meeting each quarter.
