

1 **Summary of Ordinance**

2  
3 On January 22, 2016, Lake County received a petition for establishment of a new Community  
4 Development District (District or CDD) pursuant to Chapter 190, Florida Statutes. Petitioner  
5 Kolter Acquisitions, LLC, wishes to establish the District over the Avalon Groves Planned Unit  
6 Development property in order to finance, construct and install improvements and facilities to  
7 benefit the property in multiple phases over an estimated ten (10) year period from 2016 to 2026.  
8 The Avalon Groves PUD was approved by the Lake County Board of County Commissioners in  
9 Ordinance 2012-10, and consists of approximately 971 acres located east of the Sawgrass PUD  
10 and west of the Orange County line. Pursuant to Section 190.005(2), Florida Statutes (2015), the  
11 exclusive and uniform method for the establishment of a CDD less than 1,000 acres in size shall  
12 be pursuant to an ordinance adopted by the county commission of the county having jurisdiction  
13 over the majority of land in the area in which the district is to be located. Accordingly, the  
14 purpose of this Ordinance is to establish the Avalon Groves Community Development District.

18 **AN ORDINANCE OF THE COUNTY COMMISSION OF LAKE**  
19 **COUNTY, FLORIDA, ESTABLISHING THE AVALON GROVES**  
20 **COMMUNITY DEVELOPMENT DISTRICT, AND AMENDING**  
21 **CHAPTER 20, LAKE COUNTY CODE, ENTITLED “SPECIAL**  
22 **DISTRICTS”, SECTION 20-1, ENTITLED “ORDINANCES ADOPTED BY**  
23 **REFERENCE”, TO INCORPORATE THIS ORDINANCE**  
24 **ESTABLISHING THE AVALON GROVES COMMUNITY**  
25 **DEVELOPMENT DISTRICT INTO THE LIST AS ITEM NUMBER 20;**  
26 **NAMING THE DISTRICT; DESCRIBING THE EXTERNAL**  
27 **BOUNDARIES OF THE DISTRICT; GRANTING THE DISTRICT**  
28 **POWERS UNDER SECTION 190.012(1), FLORIDA STATUTES (2015);**  
29 **NAMING THE INITIAL MEMBERS OF THE DISTRICT’S BOARD OF**  
30 **SUPERVISORS; PROVIDING FOR SEVERABILITY; PROVIDING FOR**  
31 **INCLUSION IN THE CODE; PROVIDING FOR FILING WITH THE**  
32 **DEPARTMENT OF STATE; AND PROVIDING FOR AN EFFECTIVE**  
33 **DATE.**

35 **WHEREAS**, Kolter Acquisitions, LLC (“Petitioner”), has petitioned the Board of County  
36 Commissioners of Lake County, Florida (“Board”), a political subdivision of the State of Florida,  
37 to adopt an ordinance establishing the Avalon Groves Community Development District  
38 (“District”), pursuant to Chapter 190, Florida Statutes (2015); and

39 **WHEREAS**, Petitioner is a Florida limited liability company authorized to conduct  
40 business in the State of Florida; and

1           **WHEREAS**, all interested persons and affected units of general-purpose local government  
2 were afforded an opportunity to present oral and written comments on the Petition at a duly  
3 noticed public hearing conducted by the Board on \_\_\_\_\_, 2016; and

4           **WHEREAS**, upon consideration of the record established at that hearing, the Board  
5 determined that the statements within the Petition were true and correct, that the establishment of  
6 the District is not inconsistent with any applicable element or portion of the state comprehensive  
7 plan or the Lake County Comprehensive Plan, that the land within the District is of sufficient  
8 size, is sufficiently compact, and sufficiently contiguous to be developable as a functionally  
9 interrelated community, that the District is the best alternative available for delivering  
10 community development services and facilities to the area served by the District, that the  
11 services and facilities of the District will not be incompatible with the capacity and uses of  
12 existing local and regional community development services and facilities, and that the area to be  
13 served by the District is amenable to separate special-district governance; and

14           **WHEREAS**, establishment of the District will constitute a timely, efficient, effective,  
15 responsive and economic way to deliver community development services in the area described  
16 in the Petition.

17           **NOW, THEREFORE, BE IT ORDAINED BY THE LAKE COUNTY**  
18 **BOARD OF COUNTY COMMISSIONERS OF LAKE COUNTY,**  
19 **FLORIDA, THAT:**  
20

21           **SECTION 1.    RECITALS.** The foregoing recitals are true and correct and incorporated  
22 herein by reference.

23           **SECTION 2.    AUTHORITY.** This ordinance is adopted in compliance with and pursuant  
24 to the Uniform Community Development District Act of 1980, Chapter 190, Florida Statutes  
25 (2015).

1           **SECTION 3.    DISTRICT NAME.** There is hereby created a community development  
2 district situated entirely within unincorporated Lake County, Florida, which shall be known as  
3 the “Avalon Groves Community Development District.”

4           **SECTION 4.    EXTERNAL BOUNDARIES OF THE DISTRICT.** Encompassing approximately  
5 971.265 acres of land more or less, the District’s external boundaries are described in **Exhibit A**,  
6 attached hereto and incorporated herein.

7           **SECTION 5.    FUNCTIONS AND POWERS.** The powers and functions of the District shall  
8 be those described in Section 190.012(1), Florida Statutes (2015). Consent is also hereby given  
9 to the District’s Board of Supervisors to plan, establish, acquire, construct or reconstruct, enlarge  
10 or extend, equip, operate, and maintain systems and facilities described and authorized by  
11 Section 190.012(2)(a),(d) and (f), Florida Statutes (2015), regarding parks and recreational uses,  
12 security systems, and waste collection and disposal.

13           **SECTION 6.    BOARD OF SUPERVISORS.** The five persons designated to serve as initial  
14 members of the District's Board of Supervisors are as follows: James P. Harvey, Greg Meath,  
15 David Langhout, Troy Simpson and Bradley Walker.

16           All of the above-listed persons are residents of the state of Florida and citizens of the  
17 United States of America.

18           **SECTION 7.    SEVERABILITY.** If any provision of this ordinance is held to be illegal or  
19 invalid, the other provisions shall remain in full force and effect.

20           **SECTION 8.    INCLUSION IN THE CODE.** It is the intent of the Board of County  
21 Commissioners that the provisions of this Ordinance shall become and be made a part of the  
22 Lake County Code as Item Number 20 in the list contained in Chapter 20, Lake County Code,  
23 entitled “Special Districts”, Section 20-1, entitled “Ordinances Adopted by Reference”, and that

1 the sections of this Ordinance may be renumbered or re-lettered and the word “ordinance” may  
2 be changed to “section”, “article” or such other appropriate word or phrase in order to  
3 accomplish such intentions.

4 **SECTION 9. FILING WITH THE DEPARTMENT OF STATE.** The clerk shall be and is  
5 hereby directed forthwith to send a copy of this Ordinance to the Secretary of State for the State  
6 of Florida in accordance with Section 125.66, Florida Statutes.

7 **SECTION 10. EFFECTIVE DATE.** This Ordinance shall take effect as provided by law.
