Charles D. Johnson called the meeting of the Special Magistrate to order at 9:00 a.m.

Staff was sworn in by Charles Johnson.

Diana Johnson announced the changes to the agenda and stated that Items 3 and 5 had paid their fine.

**ITEM 1**

**Noelle Munson-Malik, SM-AS-1298-16**

Noelle Munson-Malik was present and sworn.

Diana Johnson stated this case is charging the owner with repeat violation of Section 4-28 "Attack or Bite to Persons and/or Animals". Staffs recommended the Special Magistrate find the Respondent in repeat violation of this section and impose a fine of \$2,500.00.

File was entered into evidence.

Officer Laura Wright testified to the facts of the case and authenticated photos that were entered into evidence.

Complainant, Loma Reichert, was present, sworn and testified to the facts of the case.

Complainant, Rick Reichert, was present, sworn and testified to the facts of the case. Rick Reichert submitted letters into evidence.

Noelle Munson-Malik testified to the facts of the case.

Special Magistrate Charles D. Johnson accepted staff's recommended and granted 6 months to pay the fine.

**ITEM 2**

**Amber Gonzalez, SM-AS-2732-16**

Amber Gonzalez was present and sworn.

Diana Johnson stated this case is charging the owner with violation of Section 4-28 "Attack or Bite to Persons and/or Animals". Staffs recommended the Special Magistrate find the Respondent in violation of this section and impose a fine of \$1,000.00.

File was entered into evidence.

Officer Danielle Conger testified to the facts of the case and authenticated photos that were entered into evidence.

Amber Gonzalez testified to the facts of the case.

Special Magistrate Charles D. Johnson accepted staff's recommendation and granted 180 days to pay the fine.

**ITEM 4**

**Tesome Martinez, SM-AS-1270-16**

Tesome Martinez was not present at the hearing.

Diana Johnson stated this case is charging the owner with violation of Section 4-27 "Nuisance Animals" and Section 4-28 "Attack or Bite to Persons and/or Animals". Staff recommended the Special Magistrate find the Respondent in violation of these sections and impose a fine of \$2,650.00.

File was entered into evidence.


Officer Sharon Beardsley testified to the facts of the case.
