Justin Wohlgemut was present and sworn.

Diana Johnson stated this case is charging the owner with repeat violation of Section 4-27 "Nuisance Animals". Staff recommended the Special Magistrate find the Respondents in repeat violation of this section and impose a fine of \$500.00.

Dana Castro, complainant, was present, sworn and testified to the facts of the case.

Pedro Ramirez was present and sworn.


Sandra Lara, paralegal for the County Attorney's Office, was present, sworn and translated for the Respondent.
